Board of Directors Information

Article VII. Board of Directors

The board of directors shall consist of Five (5) members. Four directors shall be elected by majority vote of the members present at the first meeting following the first of March in odd years. The current past president shall automatically be appointed to the Board of Directors. The term of office shall be two (2) years. The election shall be held at the same meeting as the officer election, on odd numbered years. A vacated office will be by appointment of the President with the approval of the general membership. The Board of Directors shall elect one of their members to act as a Chairmen for their term as board members. Any elected Director may also hold a club office except the Chairman of the Board. The Board shall meet at least twice each year.

Article VIII. Duties of the Board of Directors

- A. To assist the elected officers in interpreting, implementing and integrating the policies of the club in regard to the total operating of the club.
- B. To consider and make recommendations in the matter of appointments, activities and the budget.
- C. To recommend the formation of new committees, both standing and ad hoc, as the need arises.
- D. Assist in the integrating efforts of all committees.
- E. To foster the effective involvement of the total club membership in policy formulation through active participation in club meetings, committee work, etc.
- F. To promulgate, amend and enforce rules pertaining to field safety, order, and conduct.
- G. To invoke disciplinary action in accordance with Article XVI.
